It is thereupon the 2nd day of April 2020, by the Court of Appeals of Maryland, ORDERED that the Board’s recommendation be ratified, subject to the conditions therein stated, on the 4th day of May 2020, unless exceptions to the Board’s recommendation of any UBT applicant be filed on or before said date, provided a copy of this Order be published on the Maryland Judiciary Website no later than 5 days after the date of entry and remains on the website until ratification.
